GENERAL DESCRIPTION:

Penetrates porous surfaces neutralizing cigarette, cigar, and pipe odors instantly. Also eliminates odors from pet urine.

DIRECTIONS:

Remove source of odors. Apply generously by spraying on affected area. Allow 10 to 15 minutes to dry. If odor is still present apply second application.

Preventative Use: For areas anticipating heavy build-up of odors, daily use will help to neutralize odors and freshen the area.

Vehicles: Remove source of odors. Ensure all windows are closed and no one is inside the vehicle. Turn engine on and air system on high, recirculation setting. Spray directly onto fabrics, headliner, under seats, etc. Close unlocked doors and stand outside the vehicle. Let sit for up to 10 minutes before turning off the engine.

SAFETY ON MATERIALS:

Although this product will not harm most fabrics, the fabric needs to be tested for colorfastness prior to using.

PRECAUTIONS:

HANDLING and STORAGE:
