GENERAL DESCRIPTION:

Santex provides effective sanitization, residual bacteriostatic and self-sanitizing properties for laundered items such as diapers, hospital and institutional linens, food service linens, apparel and athletic apparel. EPA Registered.

DIRECTIONS:

See product label for complete Directions and Precautions.

Use 3 oz. of SANTEX in commercial or industrial applications per a maximum total of 60 gallons [500 lbs.] of sterile tap water and a maximum of 100 pounds of fabric [dry weight]. Dilute the appropriate amount of SANTEX in one to two gallons of sterile tap water and then add this solution to the wash wheel at the beginning of the final rinse cycle. A minimum rinse cycle time of 8 minutes is required.

HANDLING and STORAGE:

Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Keep container tightly closed. Ground and bond container and receiving equipment. Use explosion-proof electrical, ventilating and lighting equipment. Use non-sparking tools. Take action to prevent static discharges. Do not breathe mist or vapor. Wear protective gloves, protective clothing and eye protection. Wash thoroughly after handling. Store in a well-ventilated place. Keep cool. Store locked up. Dispose of container in accordance with local, regional, national and international regulations.
