FOR USE AS A ONE-STEP, GENERAL, HOSPITAL, MEDICAL DISINFECTANT, FUNGICIDE, and VIRUCIDE*:

- 1. Pre-clean heavily soiled areas.
- 2. Apply use solution of 1 oz. of this product per gal. of water to disinfect hard, non-porous surfaces with a sponge, brush, cloth, mop, by immersion, auto scrubber, mechanical spray device. For spray applications, spray 6-8 inches from surface. Do not breathe spray.
- 3. Treated surfaces must remain wet for 10 minutes.
- **4.** Allow to air dry. Rinsing of floors is not necessary unless they are to be waxed or polished.
- 5. Prepare a fresh solution daily or when visibly dirty.
