### 4. FIRST AID MEASURES

#### First aid measures

##### Skin Contact

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash contaminated clothing before reuse. If irritation persists or burns occur, get medical attention.

##### Eye contact

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area. Immediate medical attention is required.

pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

## 5. FIRE-FIGHTING MEASURES
