**4. FIRST AID MEASURES****First aid measures****Skin Contact**

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. Wash contaminated clothing before reuse. If irritation persists or burns occur, get medical attention.

**Eye contact**

Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area. If irritation persists, see a physician.

**Inhalation**

If mists/vapors are formed or irritation occurs, leave area and do not return until mists/vapors have dissipated. If irritation persists, see a physician. If breathing is difficult, give oxygen. If breathing has stopped, give artificial respiration. Get medical attention immediately.

**Note to physicians**

Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.
